



Irish Sport Horse Studbook Mare Inspections Procedures and Guidelines



Applications

Application forms for mare inspections are available from the HSI website and office. Applications for inspection must be returned before the closing date of Monday 11th August 2014 and must contain the following:

- Completed and signed application form and accompanying documentation if necessary;
- Relevant Inspection Fee (€43 for paid up shareholders of the Irish Horse Board and €80 for non shareholders).

Incomplete entries will not be accepted.

All mares must be named prior to inspection. In instances where the mare is unnamed you should submit the passport and a naming application with the appropriate fee immediately to Horse Sport Ireland. Naming applications are available to download at www.horsesportireland.ie or by contacting the Horse Sport Ireland office.

Following the receipt of completed applications HSI will contact mare owners with the details of the inspection and a schedule of events.



Duration of Inspections

Mare inspections are completed in one day. Inspections will be carried out at venues during August and September 2014.

Check In

All owners must report to a HSI representative upon arrival at the centre in order to check in. At this time, all owners must present the mare(s) passport and collect entry numbers for each mare.

The entry numbers provided by HSI must be used at all times during the inspection.

Entrants must ensure they reach the inspection site in plenty of time in order to check in their mare(s).

Please note mares that have not been checked in cannot be presented at the first stage of the inspection

Presentation

All mares are expected to be presented at show standard and must be sufficiently trained and fit to take part in all aspects of the inspection. The mare should be in good condition, be well groomed and have well maintained hooves. Preferably mares' manes should be plaited, or at least be pulled and neat.

Each mare must be presented in a correctly fitted bridle.

If there is a foal present with the mare a leather head collar and canvas or leather lead should be used.

Handlers are required to dress neatly. Comfortable footwear must be worn in order to present the animal correctly. In the case where an owner has more than one horse on the premises, sufficient handlers must be on site to cater for each animal. All handlers must be dressed appropriately.

Inspection Panel

The inspection panel will consist of two inspectors. One linear score sheet and a set of overall scores will be produced from the inspectors collective deliberations.

Irish Sport Horse Mare Inspection Process

Irish Sport Horse mares must be a minimum of 3 years of age to be presented for inspection.

Mares will be given the opportunity to loose jump in order to have their athleticism assessed.

The inspection will include the following elements:

1. Pedigree assessment
2. Veterinary Examination
3. Conformation assessment
4. In hand Gait Assessment in an indoor arena
5. Free Gait Assessment
6. Free Athleticism/Jumping Assessment in jumping pen (Optional)

1. Pedigree Assessment

The mare's pedigree will be assessed and the classification/performance of the sire and dam will be taken into consideration.

2. Veterinary Examination

On arrival to the veterinary examination the identification of the mare will be checked by comparing the mare's markings to the markings on its passport. The mare will also be scanned to confirm its microchip number.

At the inspection mares will undergo a veterinary examination by Veterinary Surgeons appointed by Horse Sport Ireland. The examination will consist of the following:

Stage 1. Preliminary examination:

This includes height & bone measurement of all mares. The Preliminary Examination involves overall visual and palpable observations of the animal presented. The heart and lungs are auscultated at rest.

Stage 2. Gait assessment & Trotting up:

This includes co-ordination testing such as tight circling, reversing and trotting on loosened rein.

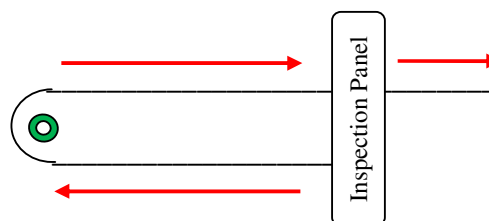
The measurements taken at the veterinary examination will be considered to be the official measurements of the mare for classification and studbook purposes.

Mares that are entered for the HSI mare inspections are subject to the HSI National Anti Doping and Equine Controlled Medication rules. Blood and urine samples may be taken from your mare for this purpose (see www.horsesportireland.ie).

3. Conformation Assessment

Handlers must present mares to the inspectors in the indoor arena for their conformation assessment using linear scoring. Mares must be able to stand correctly and quietly in order for the inspectors to make their assessment. No boots or leg wraps of any description are permitted at this stage of inspection.

The linear score sheet for Irish Sport Horse inspections contain 37 characteristics, covering conformation, movement and athleticism traits (see attached 'Sample Linear Scoring Sheet').



4. In Hand Gait Assessment in the Indoor Arena

In the indoor arena mares will be required to stand for a visual inspection. The animal must stand side view to the inspection panel to facilitate the visual assessment.

When requested the handler will move the mare in walk and then in trot.

The handler must always lead from the left side of the horse. Overuse of the whip is not permitted, the animal should be trained to show correctly.

5. Free Gait Assessment

Handlers are requested to safely release the mare and stand in one of the diamond shaped markers. The handler will have no further part in the handling of the mare for this phase of the inspection. A trained arena party will be on hand to direct the mare through its free gait, athleticism and jumping assessment.

Mares will be shown loose on both reins in trot and canter.

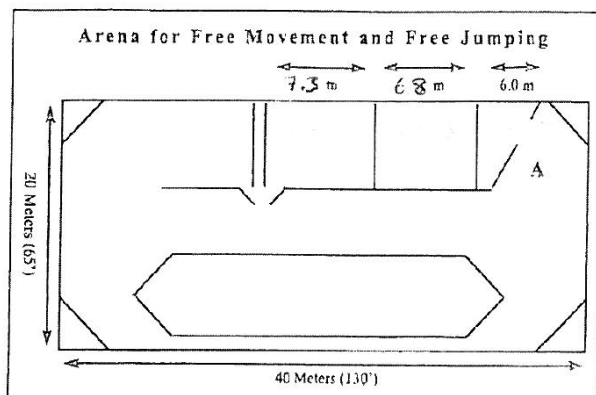
Mares with foals at foot will only be assessed on loose movement if it is deemed safe to do so by the arena party and inspection panel.

6. Free Athleticism Assessment in Jumping Pen

The jumping lane consists of three fences. The inspection panel may use their discretion as to the number of attempts they wish to assess each horse over the obstacles and the height of the fences, however the maximum height of the fences will be 1.15m and width of 1.05m.

If in the opinion of the inspection panel a horse is jumping in an unnatural manner, the inspection panel reserves the right to award zero points for their assessment of the mare's athleticism/jumping ability.

Note: Mares are permitted to wear front tendon boots for the free gait assessment or the free athleticism/jumping assessment. If, in the opinion of the inspection panel, the movement of the horse is affected in any way, the inspection panel reserve the right to request the removal of the front boots. The use of boots/bandages on the hind legs is not permitted.



Note: The elements of the inspection may not necessarily be carried out in the same order as they are outlined above. Horse Sport Ireland reserves the right to terminate any inspection for health and safety reasons.

Photographs

Photographs of mares may be taken during the inspection process by a photographer appointed by HSI. These photographs may be published in Irish Sport Horse/HSI publications.

Video footage of the inspection may also be recorded and used by Horse Sport Ireland.

Results of the Inspection

Final results will be posted to the mare owner shortly after the date of inspection and will be made available for public access on the Horse Sport Ireland website and may be published in subsequent Horse Sport Ireland publications.

Classification of Irish Sport Horse Mares Following Inspection

1. Irish Sport Horse mares that meet the veterinary requirements and the inspection requirements at inspection (minimum scores out of 100: 70 in conformation, 65 in movement) will be classified as 'Select' in the Irish Sport Horse Studbook.
2. Mares in the 'Select' class are eligible for star ratings based on their own, or their progeny's performance.
3. 'Select' mares that participate in the loose jumping phase of the inspection and achieve a score of 80 or higher in athleticism will be awarded a 'One Star' rating in show jumping.
4. Mares which do not meet the veterinary or inspection requirements will retain their original classification in the Irish Sport Horse Studbook.

Eligibility for 'Select' Inspection

Irish Sport Horse mares must be registered in the main section of the Irish Sport Horse Studbook. All Irish Sport Horse mares are eligible for inspection.

Sport horse mares that are registered in the main section of a studbook that is approved by the Department of Agriculture, Food and Marine in Ireland are eligible for inspection. The passports of such mares must be endorsed on the Irish Horse Register.

Foreign bred sport horse mares must be registered in the main section of a studbook that is a full member of the World Breeding Federation for Sport Horses (WBFSH). The passports of such mares must be endorsed on the Irish Horse Register.

Thoroughbred mares registered with Weatherbys are eligible for inspection. The passports of such mares must be endorsed on the Irish Horse Register.
