In accordance with the rules of the Society, the Board Members determined that there are five regions for the purposes of elections

with two board members per region. The five regions each contain approximately 20% of the total shareholders.

Region 1: Counties Wiekland Kilders Legis Offsly Mooth Westmooth Legth and Dublin

Region 1: Counties Wicklow, Kildare, Laois, Offaly, Meath, Westmeath, Louth and Dublin.

Region 2: Counties Wexford, Kilkenny, Carlow and Tipperary.

Region 3: Counties Kerry, Limerick, Cork and Waterford.

Region 4: Counties Mayo, Galway and Clare.

Region 5: Counties Donegal, Sligo. Leitrim, Cavan, Monaghan, Longford and Roscommon.

Please note that a number of shareholders who are resident outside of Ireland have been assigned to each of the Regions.

A vacancy arises in the current year in Region 3 in accordance with rule 47(a) which was amended at the Special Meeting of the Irish Horse Board Co-operative Society Ltd on 30^{th} May 1996.

I now invite nominations for election to the Board from members in Region 3.

Please see the nomination form below. If you wish to make a nomination, please complete the form, ensuring that it is signed by a seconder who is a member of the society and by the person proposed, who must also be a member, indicating his/her willingness to act. Please note that to be entitled to vote in the 2017 elections, the current year annual membership fee must be paid by 31st May 2017. Nominations are subject to the Rules of the Society.

Nomination forms must be received in this office by **12 noon on Friday 30th June 2017**. If more than one candidate is nominated a postal ballot will be held. Candidates will be provided with a list of the electorate in the Region.
