

Introduction

The year 2013 was my first as Chairperson of HSI and it was an honour to hold the position. I had the pleasure of meeting many great people across a wide range of equestrian activities and associated businesses. The enthusiasm, commitment and passion of all stakeholders augurs well for the future of the sport horse industry in Ireland.

A lot of people derived much pleasure from their ponies and horses during the past year: from lead-rein pony riders to European Championship stars; from leisure and pleasure riders to our national and international eventing and show jumping riders; and from breeders of children's ponies to a diverse range of horses. The horse truly has a unique place in the Irish psyche and brings people together from all walks of life and creates many new friendships and alliances. I compliment the work of the many volunteers without whom equestrian sport at all levels in Ireland could not function. The centres and shows did Trojan work to provide opportunities for enjoyment, to nurture young talent and to showcase the best we have to offer.

Therefore, no matter what category of animal or section of the sport we are interested in, we need to focus on the market requirements and trends if we expect monetary return.

Ireland is truly 'The Land of the Horse' and, as a pony and horse breeding and producing country, we should be able to supply a horse for all levels of rider and a wide range of sporting disciplines and hobbies. Everyone who aspires to be in the business end of the industry needs to try and be the very best at what they are doing and be driven by the demands of the global market. Quality will win out and, if we have the ponies and horses for the different market segments, the buyers will come. Second-rate and inferiorly bred and produced stock are nigh impossible to sell and are bad ambassadors for Ireland.



We have a 32-county industry and I thank the Government agencies and bodies, both North and South, for their support during 2013. It is important that we continue to collaborate and build on our achievements to date.

Our passion for horses and our heritage of working with and producing horses is unrivalled. People who come to Ireland to attend our international competitions, have equestrian-related holidays or to look for horses, experience a very special welcome and this experience and enjoyment makes Ireland unique globally. Our international riders are excelling in the global arenas, keeping our sport and our nation up in lights, and we have a continuous stream of fantastically talented young riders coming through the ranks. If we could produce as many four-legged champions on the international scene as we do two-legged ones, we would be in an even better place. We must nurture and encourage our young people and provide them with the horsepower, then our industry will have a very exciting future.

Working together, with mutual respect and recognition for our colleagues in the disparate disciplines and equestrian activities, all aspects of the sport will grow and prosper and we will have an industry that we can all be very proud to be a part of.

Report of the Chief Executive

There were many highlights for the sector during 2013. Our riders and horses did us proud once again in the international arena with our underage Show Jumping and Eventing teams winning a remarkable seven medals at European Championship level. This year marked five years on from the establishment of Horse Sport Ireland's High Performance structures in collaboration with the Irish Sports Council and our Affiliates. Most of the credit must go to the very talented riders, their families who support them and their owners. However, it is clear that the business model of appointing the best available High Performance Managers to run a programme with input from Affiliates, backed up by top-class coaches and vets and anchored by strong administration support from Horse Sport Ireland staff, is working.


The table on the following page shows the trend in the number of medals since the programmes were set up. While the results have been excellent we must continue to seek ways of improving the system. The introduction of the Under 25 Eventing squad during 2013 will help to

bridge the gap to senior level for successful underage riders.

During 2013, Horse Sport Ireland worked with the National Sports Campus Development Authority (NSCDA) to develop the National Horse Sport Arena on the National Sports Campus at Abbotstown. This has proved to be an outstanding facility for high performance training and has placed equestrian sport at the heart of the National Sports Campus. This development will also facilitate equestrian athletes with access to related support services provided by the Irish Institute of Sport.

Since 2008, Horse Sport Ireland has made considerable progress in bringing the sector together. There are now 27 Affiliate Bodies, including the Irish Horse Board Co-operative Society and the Northern Ireland Horse Board. A hub for the sector has been developed in Beech House in Millennium Park in Naas, where Discipline Affiliates hold meetings and many now have Head Offices located in the building.

The co-operation between Affiliates has also manifested itself in the establishment of an online searchable database. CapallOir provides pedigree and progeny information for horses registered on the Irish Horse Register. Performance links to the FEI, SJI, Eventing Ireland and AIRC results are available with further developments in train. I have always believed that the key to improving breeding is in providing information to breeders. They are the ones who make the decisions. CapallOir plays a significant part in this.

In partnership with Teagasc, Horse Sport Ireland developed the Young Breeders' Education Programme. This programme was designed primarily to educate and prepare young breeders (U25) for the World Breeding Federation for Sport Horses (WBFSH) Young Breeders' Championships. A lot of the work came to fruition in 2013 with the Irish Sport Horse Studbook team winning the Junior (U18) World Championships and coming second in the overall competition. Whether in breeding or sport, our young people are taking on the world and winning.

The Irish Sport Horse Studbook once again topped the world rankings for the breeding of three-day event horses. More importantly, seeing Irish Sport

Horses winning medals at the WBFSH World Breeding Championships for Young Horses in both Show Jumping and Eventing is a very positive signal for the future.

Late in the year, a process to develop a new Strategic Plan for the Sport Horse Sector was launched. This is a joint initiative between Horse Sport Ireland, Teagasc and the RDS. The Sport Horse Sector is worth over €700 million to the Irish economy and it is very welcome that the Minister for Agriculture has taken such a keen interest in the development of this new plan.

I would like to acknowledge the Board of Directors of Horse Sport Ireland who provide their time on a voluntary basis, as well as all the other volunteers who do so much work for Horse Sport Ireland or their Affiliate Body. Their input is invaluable. Finally, I would also like to thank the staff of Horse Sport Ireland for the huge commitment they have given to the organisation throughout the year.



High Performance Programmes



In 2008, Horse Sport Ireland introduced High Performance structures in conjunction with the Irish Sports Council and the relevant Affiliate Organisations. The programmes consist of a mix of training and target competitions aimed at preparing combinations for the challenges they are likely to face at European level. Most years, Ireland sends seven underage teams abroad to represent us in European Championships (see below). These High Performance Programmes are overseen by a High Performance Committee. The High Performance Team Manager has full selection powers. These programmes are funded by the Irish Sports Council, Showjumping Ireland and Eventing Ireland.

The progress made to date brings credit to the riders, their families, their coaches, the Affiliate Organisations, the High Performance Programmes and the HSI Coaching Programme. Having achieved such excellent results, the challenge now is to help these exceptional young athletes to make the transition to the successful senior teams.



Mare Inspections for the Irish Sport Horse Studbook and Irish Draught Horse Studbook are carried out at regional venues annually in the spring and autumn. Mares must be a minimum of 3 years of age to be presented for inspection, although Irish Draught mares can be inspected at 2 years of age. Mares undergo a veterinary examination and are assessed on conformation and movement using linear profiling. Movement is assessed in hand and loose in an arena. Owners can choose to have their mare's athleticism assessed through loose jumping for additional merits.



FEI World Breeding Eventing Championships for Young Horses – Le Lion d'Angers

The FEI World Breeding Eventing Championships for Young Horses take place annually at Le Lion d'Angers, France. These Championships consist of two competitions, a CCI 1* for 6 year olds and a CCI 2** for 7 year olds. A WBFSH Studbook competition forms part of this prestigious event, with the winning studbook awarded the World Breeding Trophy for Young Horses. In total, 104 horses are selected by their countries. In 2013, of the 104 horses selected to compete, 25 were Irish Sport Horses. Twelve of these represented Ireland and 13 represented other countries including Belgium, Great Britain, Italy, Japan, New Zealand, Sweden and the USA. In 2013, Fernhill Adventure (ISH) and Aoife Clark took second place in the CCI 2**, while the Irish Sport Horse Studbook finished second overall.



Connemara Pony Show

The Connemara Pony Breeders' Society (CPBS) hosts the Connemara Pony Show, as part of the Connemara Pony Festival, in August each year in the Showgrounds in Clifden, Co. Galway. HSI provides financial support to this show each year. The show includes loose jumping, in-hand classes, ridden classes and working hunter.

Discover Ireland Dublin Horse Show at the RDS

The Discover Ireland Dublin Horse Show is Ireland's biggest equestrian event which takes place at the RDS in August each year. Over the five days it is attended by over 100,000 visitors. It includes the five star International Show, the centre piece of which is the Aga Khan Trophy. In addition, a huge amount of other National Showing and Show Jumping Classes take place at the show. Horse Sport Ireland supports the 3 year old loose jumping competition and the 4, 5 and 6 year old National Classes for Show Jumping.

Tattersalls International Horse Trials in association with HSI

The Tattersalls International Horse Trials, in association with Horse Sport Ireland, are held annually at the Tattersalls sales complex in Ratoath, Co. Meath. Attended by over 20,000 people, the event features a number of classes at all levels and attracts the top riders from all over the world. The Irish Sport Horse Studbook is the leading studbook for event horses in the world and the HSI Breeding Sub Board considers it strategically important for Ireland to have a flagship eventing competition in the country.

Irish Farriery Authority

The Irish Farriery Authority is the umbrella body for farriery in Ireland. It is responsible for providing farriery training in Ireland and maintaining a database of practising farriers. Horse Sport Ireland provides annual funding towards the organisation's activities.

Irish Breeders' Classic

The Irish Breeders' Classic, which was initiated in 2012, is a show jumping competition for 5 and 6 year old Irish-born horses with a total prize fund of €50,000, making it the richest Young Horse Class in the world. Five percent of the overall prize fund goes to breeders, with breeders' prizes of €3,000 provided by Horse Sport Ireland. The prize fund is generated by voluntary contributions from organisations and individuals within the Irish Sport Horse industry.

Irish Sport Horse Studbook Showjumping Series 2013

The Irish Sport Horse (ISH) Studbook Showjumping Series 2013 consisted of eight legs held across the summer from April to July. The Studbook Series 2013 was open to horses with the breed codes ISH, RID or ID that were registered in the Irish Horse Register (IHR), and with sire and dam documented on their passport. ISH Young Breeders' Programme

Established in 2006, the ISH Young Breeders' Programme is a joint programme between Horse Sport Ireland and Teagasc. The programme is aimed at young people (14-25) who are interested in assessing, exhibiting and breeding performance horses.

The WBFSH Young Breeders' World Championships take place every two years, with the next World Championships scheduled for Hartpury in August 2015. The National Championships will also take place in 2015. Participation at the National Championships is necessary to qualify for selection to represent the ISH Studbook at the World Championships.

Five Key Areas

- ▶ Theory (stable management, the sport, breeding, feeding, health and welfare)
- ▶ Assessment of conformation
- ▶ Assessment of loose movement and loose jumping
- ▶ Presentation of horses in hand using the triangle system
- ▶ Turnout of horses

Training Programme

Young breeders attend a training programme before the National Championships. Training is based on the core values of breeding and producing performance horses. Training days in the lead-up to competition principally cover assessment of conformation, movement and jump and presentation of horses in hand. At other times of the year training includes discussion of markets and market value; type of horse for the individual markets; production of horses for sale; practical stable management and husbandry; course

walks with coaches/experts; visits to breeding facilities; audiences with riders and industry professionals. The skills gained become invaluable when purchasing a new horse/pony; deciding which mares/stallions to use for breeding; assessing offspring; presenting horses for inspection, sale, show or competition. Senior Young Breeders (18-25) can attend arena party training for loose movement/jumping at HSI Mare and Stallion Inspections.

Overall Reserve Champions 2013

The Irish Sport Horse (ISH) Studbook Young Breeders Team enjoyed a superb year in 2013 at the World Championships in Sweden. Each studbook was represented by a Senior Team (20-25) and a Junior Team (17-19). The ISH Studbook Young Breeders Team – sponsored by Connolly's Red Mills and one of 20 teams to take part – put in an incredible performance to finish as Overall Reserve Champions, second only to the Holstein Studbook team.

The ISH Studbook Young Breeders Senior Team consisted of Rossa Gallagher (Meath), Iris Brazil (Westmeath), Regina Daniels (Galway), with Ciara Greaney (Dublin) in reserve. Iris Brazil won the Loose Jumping division in the Senior Competition. The ISH Studbook Young Breeders Junior Team won the Junior Competition. The winning team consisted of Alyssa O'Neill (Kildare), Caoimhe Kenny (Laois) and Orla Dooley (Kilkenny), with Ruaidhri Ó'Cianain (Galway) in reserve. Orla Dooley won the Overall Individual Junior Championship and the In-Hand section. Alyssa O'Neill was third and Caoimhe Kenny was fourth overall individually in the Junior Competition. Alyssa O'Neill finished third in the Conformation section.

Located within the Walled Garden of Abbotstown House, a protected structure, the new arena will give Irish equestrian athletes access to world-class facilities for a diverse range of equestrian sports. Developed in accordance with the High Performance training needs of equestrian riders,

under the technical guidance of Horse Sport Ireland and its Affiliates, it is the first publicly-owned facility of its kind in Ireland and will be managed by the National Sports Campus. The National Horse Sport Arena is the main base for Team Ireland Equestrian training. With 10 stables on site, athletes can rest their horses before or after training as required. Riders can avail of other facilities on site as well as coaching and rehabilitation services. The arena will be available on a 'community commercial' basis to those aspiring for success in international competition.



Irish Horse TV is the first ever online TV station dedicated to all things equestrian. The channel was launched on 5th February 2013 at The K Club in Straffan, Co. Kildare. Horse Sport Ireland and Horse Racing Ireland are founding partners, with Connolly's Red Mills as the main commercial sponsor. Sponsorship was also secured from founding members the RDS and the Irish National Stud. This innovative online TV channel is free to watch anytime from anywhere in the world on any device connected to the internet. Content includes news features on racing and the Olympic disciplines of Showjumping, Eventing and Dressage, as well as other equestrian pursuits. HSI's weekly Equestrian News covers Irish-bred horses competing on the world stage. The station

is targeted at domestic and international audiences and reinforces Ireland's image as the 'Land of the Horse'. Just one month post launch, online viewing figures had risen to 38,000. The channel can be viewed at www.irishhorse.tv

The Irish Horse Gateway (IHG) is an initiative that connects the world to the Irish horse. Launched by Horse Sport Ireland in May 2013, this sales channel for sellers of Irish-bred horses and ponies began operating commercially in September 2013.

The aims of the initiative are to help breeders and producers in Ireland to sell high-quality Irish-bred horses and ponies in international markets; to give foreign buyers increased confidence in buying horses and ponies in Ireland; to assist foreign buyers in sourcing reputable providers of other services; to provide market feedback to Irish breeders and producers.

Sellers register by signing a Code of Conduct, allowing them to advertise horses or ponies for sale. One year's membership costs €99 plus VAT for an unlimited number of adverts. All revenues are reinvested in building the brand internationally. All horses must be registered in an approved studbook and have recorded pedigree. Middle East Trade Mission

Horse Sport Ireland was invited by the Minister for Agriculture, Food and the Marine, Simon Coveney, to be part of the Gulf States Trade Mission from 26th October to 1st November, 2013. The delegation for the Trade and Investment Promotion Programme included officials from the Department, Bord Bia, Enterprise Ireland, Horse Sport Ireland, Horse Racing Ireland, Irish Thoroughbred Marketing and the Embassies of Ireland to the Kingdom of Saudi Arabia and the UAE. Approx. 60 representatives from Irish businesses also travelled with the group. The trade mission visited equestrian clubs and facilities in Doha, Qatar; Abu Dhabi, UAE; and Riyadh, Saudi Arabia, where the group visited the King's Stud of His Majesty King Abdullah Bin A'Aziz Al Saud. The objectives of the trade mission were to develop relationships between Ireland and the Gulf States in the equine sector; promote Ireland's image as a source of thoroughbreds and sport horses and a strong equine education provider; encourage the Diaspora to promote Ireland's equine sector; and to promote Horse Sport Ireland.



HSI Coaching Programme

The Horse Sport Ireland (HSI) Coaching Programme is designed to provide candidates with a pathway to a career as a successful competition coach. HSI Coaching courses are delivered by professional equestrian tutors and use modern techniques to improve both horses' and riders' performance. Coaching courses are currently delivered across four levels and are accredited by Coaching Ireland, the Irish governing body for coaching in all sports.

The HSI Coaching System is a competition-based coaching system and focuses solely on coaching. The courses offer a better understanding of modern competition requirements, coaching skills, technical knowledge and principles of good communication, so they are also suitable for parents, breeders, young horse producers, competitors, riding school instructors and anyone involved with – or with an interest in – horses and the industry.

Since the HSI Coaching Programme has been operational it has delivered hundreds of courses all around Ireland and further afield. The HSI Coaching System has been adopted by the British Equestrian Federation (BEF) and the Fédération Equestre Internationale (FEI).

HSI National Anti-Doping Programme

In 2013, the second year of the National Anti-Doping Programme, a total of 114 horses were sampled with only one positive result. FEI Clean Sport

The Fédération Equestre Internationale (FEI) carries out testing on horses at international competitions. Ireland is placed in Groups I and II for the FEI Equine Anti-Doping and Controlled Medication Programme (EADCMP). In 2013, a total of 3,982 horses were tested worldwide and 2,946 of those were within Groups I and II. Six of those tested from Groups I and II were horses and ponies ridden by Irish riders in international competitions. All of the samples taken were found to be clean when tested in FEI laboratories. No horse ridden by an Irish rider has tested positive in an FEI competition since 2008.

1. ACCOUNTING POLICIES

Basis of accounting

The financial statements are prepared in accordance with generally accepted accounting principles under the historical cost convention and comply with financial reporting standards of the Accounting Standards Board, as promulgated by the Institute of Chartered Accountants in Ireland, and Irish statute comprising the Companies Acts, 1963 to 2013.

Turnover income

Income includes grant amounts received from the Irish Sports Council and the Department of Agriculture grant funds and income received from registrations and related activities.

Fixed assets

All fixed assets are initially recorded at cost.

Depreciation

Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows:

Leasehold Property	-	(25% Straight Line)
Fixtures & Fittings	-	(25% & 50% Straight Line)
Equipment	-	(25% Straight Line)

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Operating lease agreements

Rentals applicable to operating leases where substantially all of the benefits and risks of ownership remain with the lessor are charged against income on a straight line basis over the period of the lease.

Foreign currencies

Assets and liabilities in foreign currencies are translated into Euro at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into Euro at the rate of exchange ruling at the date of the transaction. Exchange differences are taken into account in arriving at the operating surplus.






