- A financial basis was established for the IHB Co-operative and shares are offered at a rate of €10/£10 per share.
- Payment of Annual Renewal fees (€25/£23) is required in subsequent years to remain an Active Shareholder.
- IHB Shareholders/Members are entitled to discounted Irish Horse Register (IHR) transaction fees.
- IHB Active Shareholders receive certain Horse Sport Ireland breeding publications free of charge since 2008.
- IHB Shareholders/Members enjoy open access to the Irish Horse Database online (formerly CapallOir).
- Each IHB Shareholder will have only one vote at the IHB AGM, irrespective of the number of shares held.
- It is not envisaged that IHB shares will appreciate in value.
