



DAFM Autumn Development Series 2025: Dressage

Horse Sport Ireland are delighted to announce the 2025 DAFM Dressage Autumn Development Series, this will include a selection of horse and pony classes. This year, the DAFM Dressage Development Series will run as three legs with €15,000 in funding available across the series with prizes for 4-, 5-, 6-, & 7&8-Year-Old horses and 5- & 6&7-Year-Old ponies as well as breeders' prizes.

The dates and venues for the 2025 DAFM Dressage Development Series are as follows:

- **October 4th (H&P) Millstreet**
- **October 12th: (H&P) Danescroft**
- **October 18th: (H&P) Marlton**

(H&P) Horses & Ponies

Notes on 2025 Series:

It is the responsibility of riders, and their guardians where relevant, and owners to familiarize themselves with all criteria in this document.

Entries:

- All DAFM Development Series classes must run on a pre-entry basis made through Dressage Ireland
- Entries must be made via an online portal. No other form of entry will be accepted
- Ponies can be ridden by adult or pony athletes
- For Dressage Ireland nonmembers, day tickets will not be accepted.
- Each leg is a standalone competition.

Late entries will be charged double the class entry fee. Late entries can be made via the Dressage Ireland website. Entries will be no more than €30 (£25) per class.

Eligibility:

- Classes are restricted to horses/ponies registered in a **studbook with a valid, listed breed** contained within the studbook passport (UNK is not a breed).
 - Main and Supplementary section studbook animals are permitted.
 - Pedigree recording with an 'UNK' breed code is not a studbook passport and not eligible for entry/prizemoney.
 - Breeder's prizes will only be paid to breeders residing on the Island of Ireland.
 - All studbook horses born outside of the island of Ireland entering the DAFM Development Series must be lodged with an Irish PIO prior to entry or participation in the league.
 - HSI will not accept responsibility nor provide prize monies to any combination who do not meet this criteria.

Horse Sport Ireland reserve the right to change or alter the terms and conditions of the DAFM Autumn Development Series at any time.



At the show:

The DAFM Dressage Autumn Development Series, delivered by Horse Sport Ireland, must be organized and run in full compliance and adherence of Dressage Ireland rules. The designated pony classes are as listed.

Combinations entered to compete in these classes are strictly limited to warming up in the designated practice arenas. Any athlete found in breach of this rule by the DI steward will be eliminated from the class. Riders who choose to compete in a leg(s) of the DAFM Dressage Autumn Development Series are consenting to their rounds being live-streamed and/or available for publication on platforms of Horse Sport Ireland's choosing.
