Foreword



The Irish Cob is one of Ireland's native breeds, recognised worldwide for its strength, versatility, excellent temperament and distinctive bone and feathering. As operators of the Irish Cob Studbook, Horse Sport Ireland is committed to supporting breeders, safeguarding genetic diversity and the long-term sustainability of the population. This report provides an evidence-based overview of the current status of the Irish Cob Studbook and highlights the progress being made through breeding programme implementation, breeder engagement and the application of emerging genomic technologies.

The success of any breeding programme is ultimately dependent on breeder participation, and I am delighted to see the strong and growing engagement of Irish Cob breeders with the studbook. Since 2022, participation in the Irish Cob and Irish Part-Bred Cob inspection system has increased by 150%, with 2025 representing a record year, maintained into 2026. This growth reflects breeder confidence in the inspection process and the value it delivers through breed assessment, veterinary examination, SNP genotyping, validated trait recording and transparent publication of results. This remains one of the most important knowledge transfer tools available to breeders, providing practical guidance to support informed breeding decisions while ensuring horses entering the studbook meet the Irish Cob breed standard.

Horse Sport Ireland continues to work closely with breeders to ensure that the breeding programme remains relevant, practical and responsive to industry needs. Through ongoing breeder consultation, continual refinement of classification systems and a structured process for considering breeding programme amendments, we remain committed to continuous improvement. We also continue to engage with the Department of Agriculture, Food and the Marine regarding the application for rare breed status, reflecting the importance placed by breeders on the conservation and recognition of the Irish Cob.

I hope that the findings presented will provide valuable insights and support informed decision-making as we continue to build a sustainable future for the breed.

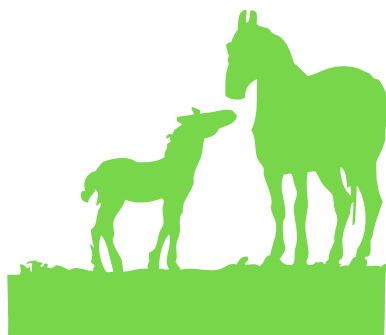

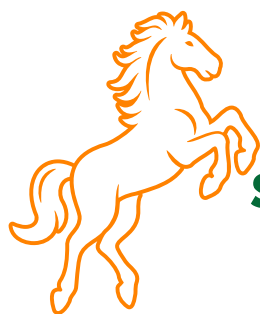

Introduction

The Irish Cob is a native Irish breed and, although it has a long history, the Irish Cob and Irish Part Bred Cob studbooks were only officially founded in 1998 with Horse Sport Ireland maintaining the studbooks since 2013. Prior to this, cob lineages were passed down verbally from generation to generation. The breed is referred to worldwide by many different names such as Gypsy Cob, Gypsy Horse, Gypsy Vanner and Irish Tinker. The overall aim of the breeding programme for the Irish Cob is the preservation (conservation) of the breed and the improvement of individual horses within the breed towards the breed standard while the aim of the breeding programme for the Irish Cob Part-Bred is the improvement of the breed.

Numbers of Irish Cobs and part-bred Cobs being registered each year is small with on average, a combined 105 foals being born into both studbooks. However, the number of horses being registered late or being registered on identity documents before being inspected into one of the studbooks makes this difficult to accurately assess until several years past the year of birth. Foals are legally required to be registered within 12 months of birth under EU Regulation 2015/262, and foals not registered within this time frame have an increased registration cost and are automatically stamped out of the food chain. With a breeding objective focused on conservation, it is important that breeders abide by these timelines to enable accurate assessment of Irish Cob population statistics.

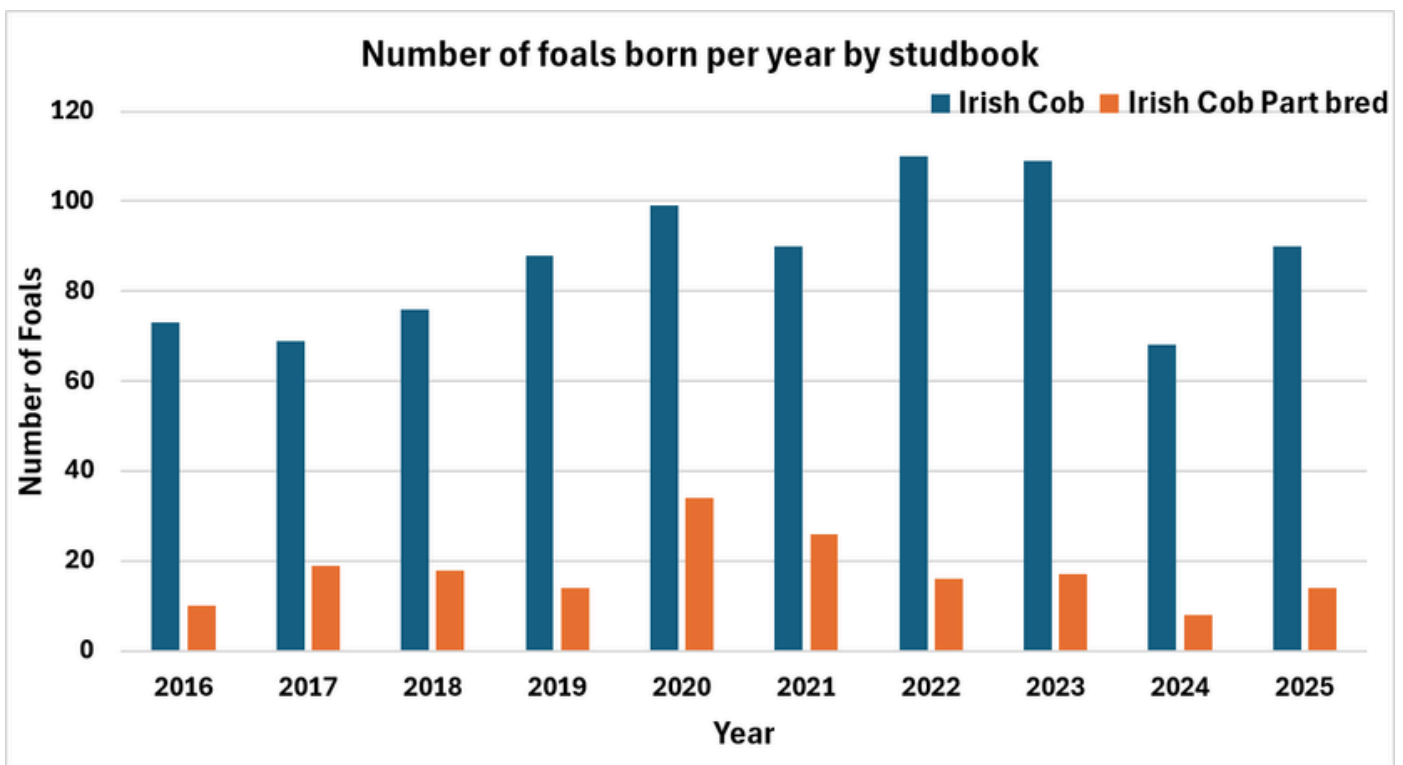
Irish Cob and Irish Cob Part-Bred studbook inspections for mares and stallions are carried out annually in the spring and autumn. Equines must be a minimum of 3 years of age to be presented for Irish Cob and Irish Cob Part-Bred studbook inspections. At Studbook inspections Irish Cob and Irish Cob Part-Bred stallions are assessed on their conformance to the breed standard and their conformation and their movement in hand in walk and trot. Conformation is assessed through a 13 trait profile on a (poor) 1 - 5 (strong) scale, with an additional 3 scores for Excellence of Breed Type, Presence and Movement. The scale details the minimum scores required for the presented animal to achieve Class 1 and the minimum scores required to enter the Studbook through breed type (3 or higher).

The full breed standard of the Irish Cob and Irish Part Bred Cob are outlined in their relevant breeding programmes, available on the HSI [website](#). Irish Cobs have an imposing appearance with a stout, powerful body. They are noted for their high knee action, excellent temperament and natural distinctive feathering, mane and tail. Their wide short backs make them comfortable under saddle and they are suitable for a wide range of riding and driving disciplines.



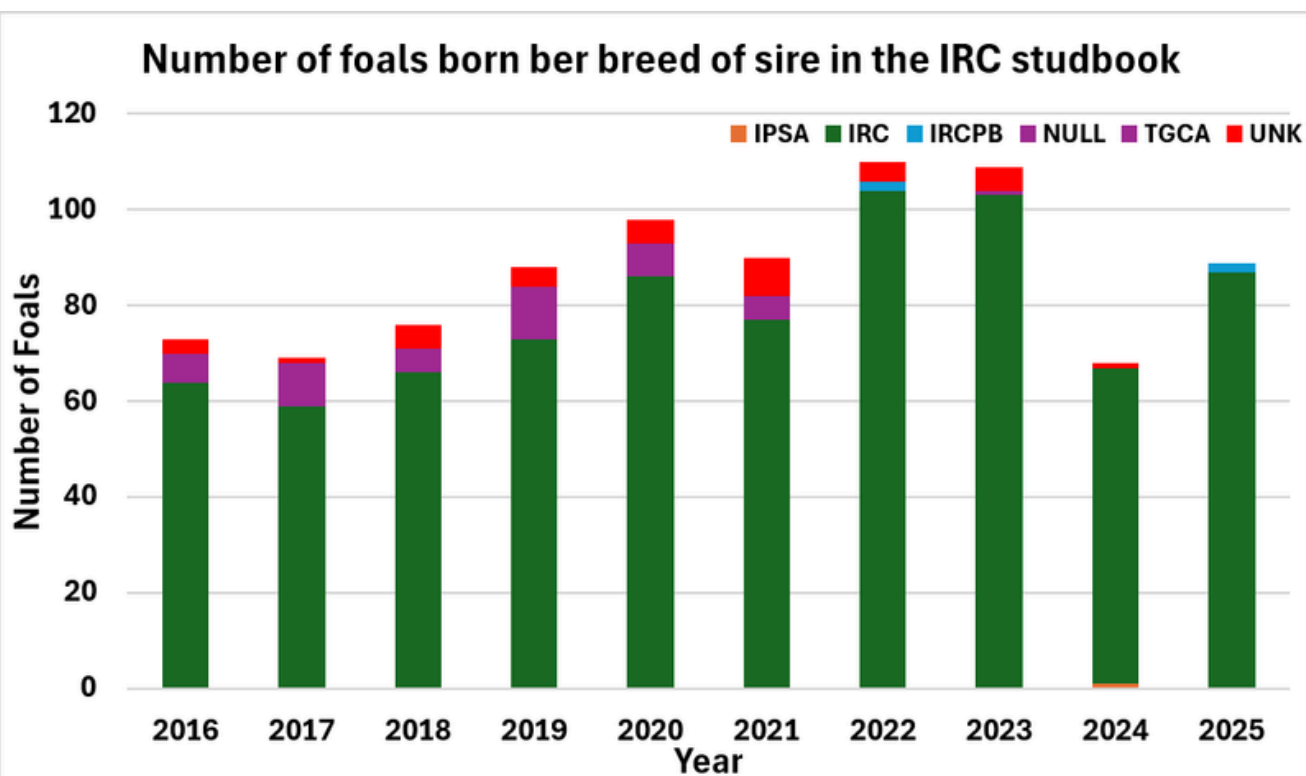
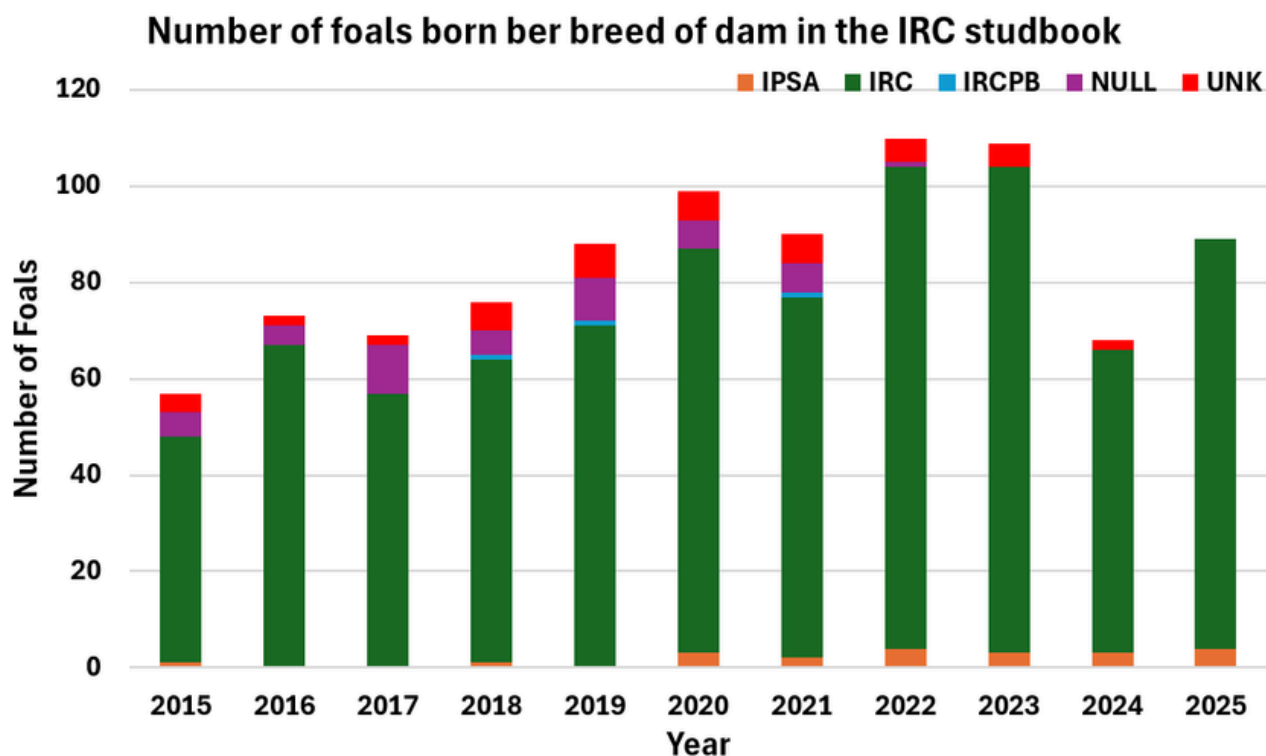
Population Statistics

In the last decade, the Irish Cob (IRC) studbook has 87 foals registered on average per annum, while the Irish Cob Part Bred (IRCPB) Studbook registers 18 foals per year on average. In general, the number of foals being registered in the IRC studbook is trending upwards and we would still expect the numbers of foals born in 2024 and 2025 to increase as late registrations are common.



The IRC studbook is not a closed studbook and allows males and females from several studbooks which meet specific criteria to enter the crossbreeding program. Males and females registered with Irish Piebald and Skewbald Association (IPSA), the Gypsy Cob Association (TGCA), or as a Coloured Horse, or Tinker are eligible to enter the main section of the Irish Cob Studbook. Females from the IRCPB and Welsh Cobs can also enter the crossbreeding programme upon presentation for inspection.

In comparison, there is no limit to the horse and pony studbook breeds which can be used to cross with the Irish Cob to produce a horse registered in the IRCPB studbook. Animals that are registered in a studbook recognised by their relevant Competent Authority can take place in the crossbreeding programme and shall be classified in the Main section of the IRCPB. Dam breeds that have contributed to the IRCPB include the Irish Draught, Connemara Pony, Thoroughbred, and Irish Sport Horse.





The active number of stallions producing an IRC or IRCPB foal varies widely within year. In 2023, there were 31 stallions active within the IRC studbook but this had been as low as 15 active stallions in 2017. The number of stallions active in the IRCPB studbook is much lower, as expected with the foal registrations being lower. In 2021, 16 individual stallions contributed to the IRCPB studbook but this has been much lower in other years. The average number of IRC/IRCPB progeny per stallion is very low with the average number of foals per stallion always below 3.93 in the IRC studbook and 2.83 in the IRCPB studbook.

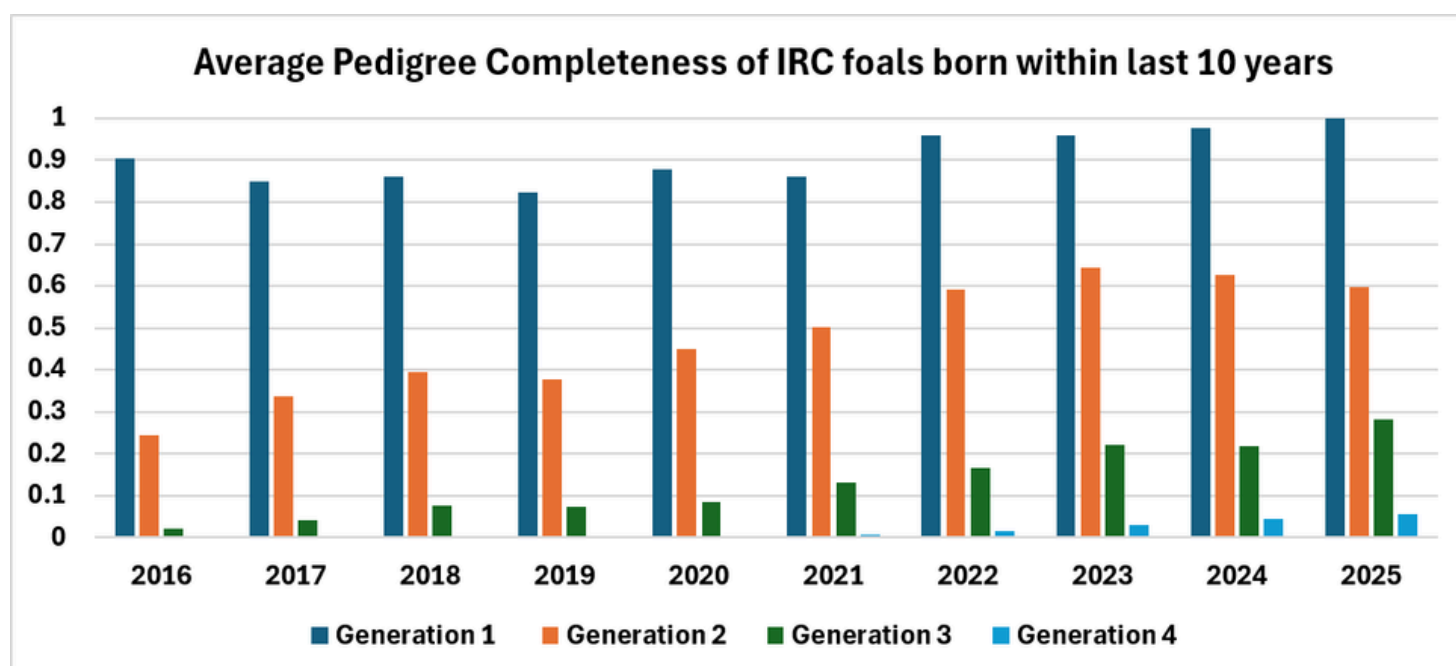

Pedigree Completeness

The Pedigree Completeness Index (PCI) measures the proportion of known ancestors in an individual's pedigree over a given number of generations. It is a vital quality control metric in animal breeding programmes as the completeness of an animal's pedigree affects other important metrics in conservation genetics such as pedigree inbreeding calculations and kinship estimations. Inbreeding coefficients rely on knowing both maternal and paternal ancestors and if one or both of these ancestors are unrecorded, standard pedigree calculations of inbreeding will assume the ancestors are unrelated and that the inbreeding is 0.

As the PCI measures the proportion of known ancestors in an individual's pedigree over a given number of generations a PCI of 1 at generation 1 means both parents are recorded, a PCI of 0.5 at generation 1 means only one parent is recorded, a PCI of 1 at Generation 3, where an animal has 8 ancestors (great-grandparents) means all 8 ancestors are recorded, a PCI of 0.875 at generation 3 means one ancestor is missing, and a PCI of 0.75 at generation 3 means two ancestors are missing, and so on. In other breeds, we regularly see an average PCI at generation 3 of close to 1. However, in the IRC studbook the average PCI at generation 3 is down at 0.28 as horses with unknown breeding can be inspected in to the studbook to produce progeny. The PCI at all generations has been trending upwards showing an increase in pedigree registrations for this breed.





Inbreeding

Inbreeding, also known as linebreeding, is the production of an offspring from the breeding of closely related individuals. While inbreeding can make it easier to predict what traits will be passed on to the offspring, it also makes it more likely that the offspring will inherit negative characteristics including certain health defects and diseases.

The inbreeding coefficient is the measurement of the degree of inbreeding and is usually given as a percentage. Typical inbreeding percentages, assuming no previous inbreeding between any parents, are as follows:

- Sire/daughter or Dam/son mating → 25%
- Full sibling mating → 25%
- Half sibling mating → 12.5%
- Grandsire/granddaughter or granddam/grandson mating → 12.5%
- Uncle/niece or aunt/nephew (aunt/uncle and parent are full siblings) → 12.5%
- Parents have a common grandsire/granddam (First Cousins) → 6.25%
- Parents have a common great-grandsire/great-granddam → 3.125%

In the IRC and IRCPB, it can be difficult to get a complete picture of the true pedigree inbreeding as many horses registered in these studbooks do not have much pedigree recorded. For the purpose of the calculating the inbreeding coefficients below, all horses included in the calculation had a PCI at generation 2 of 1. While most horses had an inbreeding coefficient of 0%, the maximum inbreeding calculated for an IRC foal was 12.5%.

Classifications

In 2024, HSI updated the Irish Cob and Irish Part Bred Cob breeding programme rules to reflect a new classification system for the IRC and IRCPB studbooks. The previous system was deemed overly complicated and was confusing for the studbook community.

The main section of the IRC and IRCPB studbooks are divided into four classes in accordance with the standard a horse meets. All foals are entered into Class 4 on registration into either of these studbooks. Upon presentation at a selection day, these horses are upgraded to either Class 1, Class 2 or Class 3 depending on the veterinary and inspection requirements they meet.

The supplementary sections of both studbooks is divided into very similar classifications, these are Supplementary Class 1 and Supplementary Class 2. Mares and stallions are encouraged to come forward and present at studbook selection days to gain classification and to ensure they have no veterinary conditions deemed unsuitable for a breeding mare or stallion by the Irish Cob Studbook breeding programme.

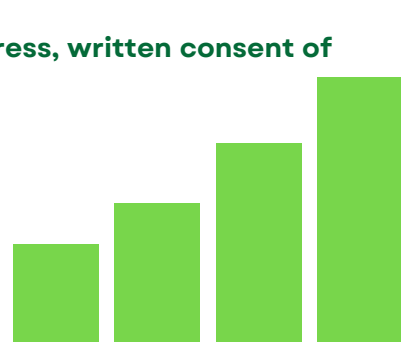
