



## 2019 FEI RECOGNITION CARD APPLICATION, UPDATES TO EXISTING FEI RECOGNITION CARDS & REGISTRATIONS

IS AN FEI RECOGNITION CARD NECESSARY? An FEI recognition card is required for all FEI competitions with the exception of horses competing in their home country at CSI1\*/2\* (show jumping), up to CCI3\* S & L (eventing) and CEI1\*/2\* (endurance) and CPEID2\* (para equestrian). PARTICIPATION AT ANY FEI (INTERNATIONAL COMPETITION) IN A FOREIGN COUNTRY REQUIRES AN FEI recognition card (exception borrowed para-equestrian horses). **IMPORTANT - please enclose the horse/pony's national passport with your application**

### Creation of an FEI recognition card

Horse: €220, Pony: €150 (a revalidation card is valid for 4 years, it's the owners responsibility to check that it is in date) **Horse name:** \_\_\_\_\_

### Change of FEI ownership

€80 (if the horse is an ISH then the change of ownership in the ISH passport is included in this charge)  
Only needed for horses that are already FEI registered, not needed for new FEI horse registrations or new FEI recognition cards

### Change of FEI horse/pony name/adding prefix

€1000 (see current FEI [naming rules](#) for details)

### Revalidation of FEI recognition card

Horse:€215, Pony: €145 (a revalidation card is valid for 4 years, it's the owners responsibility to check that it is in date)

### Duplicate FEI recognition card

€80 (if the national passport has been lost as well please apply for a national passport copy before applying for an FEI recognition card)

You'll have to pay the following emergency charge if you need to receive your FEI recognition card or any of the above changes on the day. Horse/Pony recognition card €20.

### Registration of Horse/Pony with the FEI

€35 (a horse/pony that competes at FEI competition in Ireland or abroad needs to be registered every calendar year) **Please state discipline to register the horse/pony in here: SJ/Eventing/etc.** \_\_\_\_\_

#### OWNER'S DECLARATION
