**Data Statement:** I, the undersigned, understand that pursuant to the Data Protection Act 2018 and the General Data Protection Regulation (GDPR) 2016, my consent is required for Horse Sport Ireland (HSI) to process personal data which it may have in its possession concerning me including disclosure to third parties such as, but not limited to, the HSI's Registration Unit Administrators, HSI's Breeding Department, the Department of Agriculture, Food & the Marine (DAFM), the Department of Agriculture, Environment & Rural Affairs (DAERA – NI) and the Department for Environment, Food & Rural Affairs (DEFRA – UK). I note that HSI will honour my rights and freedoms at all times, including my rights as a data subject, as long as there is no overriding law which limits those privileges. I note that HSI may use the horse data supplied for studbook purposes, breed improvement research and future promotion of the breed and that it may be used in HSI publications, media outlets and online platforms.

# Endorsement Information



## Points to Note:

1. This identity document was issued by an Irish Passport Issuing Authority and if a change of ownership is required, the passport will need to be forwarded to the issuing PIO for a change of ownership
2. Please indicate overleaf, the studbook into which you want to endorse the animal.
3. You need to indicate the reason you are endorsing the animal (ie for breeding purposes, competition, pedigree purposes, etc.)
4. This form is used for passports issued by the following organisations
  - a. Weatherbys Ireland
  - b. Connemara Pony Society
  - c. Leisure Horse Ireland
  - d. Warmblood Studbook of Ireland
5. If the animal does not fulfil the requirements for the crossbreeding programme for the studbook for which they applied, they will remain unclassified on the IHR until they present and are passed at Inspection

**Equine Premises Number** - It is a legal requirement under the Control on Places where Horses are Kept Regulations (SI 113 of 2014) that all premises where equines are kept must be registered with the Department of Agriculture. Accordingly, you should ensure that your equine is being kept on a registered premises. If your holding is not already registered as an Equine Premises, you should apply immediately to DAFM for an Equine Premises Number as this application cannot be processed without this number.

## Further points to note:

1. The passport is not a deed of ownership
2. This document is a legal declaration (with penalties under the Animal Health and Welfare Act 2013.)
3. It is a legal requirement that the document of Identification (passport) should always accompany the equine.
