



## CSI OP – CSI P – CSI YP FONTAINEBLEAU (FRA) 28<sup>th</sup> April – 1<sup>st</sup> May 2022

For 2022, results of the Showjumping Ireland Equijump Spring Tour will be used to allocate places for TEAM event([CSIOP Fontainebleau, \(FRA\)](#)).

The following selection system will apply:

- The FEI Invitation System for Fontainebleau states that **CSIOP athletes** are permitted to compete with (2) Ponies in the CSIOP Category.
- Furthermore, the CSIOP athletes are permitted to compete in the Young Pony classes (YP), each CSIOP athlete can enter one 6-year-old and one 7-year-old; **or** two 6-year-olds, **or** two 7-year-olds. Please see official [Fontainebleau CSIO FEI Schedule](#), invitations system at Appendix 1.
- CSIOP Athletes cannot compete in the CSIP classes.
- In order for IRL athletes to avail of the places at Fontainebleau, the following selection system will apply:
  - For the CSIOP Nations Cup Squad, please see Ranking System below. Where selected CSIOP athletes wish to avail of the YP allocation the following criteria applies:
  - The **CSIYP (6-year-old)** must have been seen on the Equijump Spring Tour on three occasions at any leg of the tour and have attained two first round clears out of three rounds in the 1.10m class.
  - The **CSIYP (7-year-old)** must have been seen on the Equijump Spring Tour on three occasions at any leg of the tour and have attained two first round clears out of three rounds in the 1.20m or 1.30m class.
- The additional **CSIYP Ponies** must be approved by the Team Manager as being of sufficient standard to compete in Fontainebleau.

### CSIOP – Nations Cup Ranking System

- Places on the Nations' Cup squad will be allocated based on the **three lowest fault performances from the following four 1.30m classes** which take place as part of the Equijump Spring Tour.

20 <sup>th</sup> March 2022	Portmore
26 <sup>th</sup> March 2022	Mullingar
4 <sup>th</sup> April 2022	Maryville

- Athletes should note that they are required to compete **at all four identified events** with the best three counting, as noted above.
- Each combination's three lowest total fault scores from the **first round** in each of these 1.30m classes from the four designated venues will count towards their overall ranking for the allocation of places in Fontainebleau.
- In the case where combinations finish level having accumulated the fault totals as set out above, the combinations finishing position in the first round of the 1.30m class at Maryville (4<sup>th</sup> April) will determine their ranking compared to the other combinations that finish on the same accumulated score.
- The first five combinations in the rankings will be allocated a place on the Nations' Cup squad for **Fontainebleau (FRA) 28th April – 1st May 2022**. The Jumping High-Performance Team Manager will, based on his expertise and knowledge of the combinations involved, select the four combinations to jump for Ireland in the Nations' Cup from amongst the five that travel as part of the squad.

### **RANKING SYSTEM CSIP (10 Combinations)**

- The next 5 combinations from the 1.30m rankings (**6th to 10th**) will be allocated places in the CSIP competitions by the HSI High Performance Pony Jumping Committee in consultation with the SJI Pony Committee.
- The 5 top ranked combinations from the 1.20m rankings will then be allocated the remaining 5 places in the CSIP competition by the HSI High Performance Pony Jumping Committee in consultation with the SJI Pony Committee.
- Each combination's three lowest total fault scores from the first round in each 1.20m class will count towards their overall ranking for the allocation of CSIP places. At least two of the fault scores must be zero.
- In the event of tied fault totals, the combinations finishing position in the first round of the 1.20m class at Maryville 4<sup>th</sup> April will determine their final ranking.
- Any combination who does not compete at Maryville 4<sup>th</sup> April will be considered to have finished behind those who did compete in the final leg for the purposes of resolving tied fault totals.
- Any combination can compete Hors Concours (HC) in the spring tour and still be ranked for Fontainebleau selection purposes. This enables them to remain within the RDS 2022 points thresholds.
- For the avoidance of doubt, combinations can attempt to secure a place in Fontainebleau CSIP classes through both the 1.20m and 1.30m rankings.

### **RANKING SYSTEM CSIYP (10 combinations)**

- Athlete combinations should note that priority will be offered to the CSIOP athletes in the first instance as per the FEI Schedule, in that CSIOP athletes are entitled to bring two additional ponies to compete in the CSIYP, 6-year-old and CSIYP 7-year-old.
- Thereafter, any **unused quota places** will be allocated as follows:
- The 10 top ranked combinations from their respective classes will be eligible for quota allocation in the Fontainebleau CSIYP competitions by HSI High Performance Pony Jumping Committee in consultation with the SJI Pony Committee.
- 6-year-old ponies are eligible for allocation in the **CSIYP 6-year-old** classes through the Spring Tour 1.10m rankings only.
- 7-year-old ponies are eligible for allocation of a place through either the 1.20m or the 1.30m Spring Tour rankings but may only compete in the **CSIYP 7-year-old** classes in Fontainebleau.
- Athletes should note that they are required to compete **at all four identified events** as noted above with the best three counting.
- Each combination's three lowest total fault scores from the first round in each of their respective classes will count towards their overall ranking for the allocation of CSIYP places. At least two of the fault scores must be zero.

- In the event of tied fault totals, the combinations finishing position in the first round of their respective classes at Maryville 4<sup>th</sup> April will determine their final ranking.
- Any combination who does not compete at Maryville 4<sup>th</sup> April will be considered to have finished behind those who did compete in the final leg for the purposes of resolving tied fault totals.
- A combination can compete Hors Concours (HC) in the spring tour and still be ranked for Fontainebleau selection purposes. This enables them to remain within the RDS 2022 points thresholds.
- Athletes should note that the HSI High Performance Pony Jumping Committee in consultation with the SJI Pony Committee reserve the right not to allocate a CSIYP places, notwithstanding the ranking of such athlete combination.

### Veterinary Obligations and Pony Measuring

- All Ponies intending on travelling to the CSIOP and any additional Ponies travelling for the CSIP and CSIYP are required to have a valid FEI Recognition Card and 2022 FEI Pony Registration together with up-to-date vaccinations. - Athletes, personal management teams, private coaches are strongly encouraged to ensure that Ponies meet or are within the stated Regulatory Height.
- Athletes, personal management teams, private coaches are to ensure that the equine passports are up-to-date vaccinations and/or flu boosters, as required.

## Force Majeure

- In the event of one of the designated events being cancelled the Pony Jumping High Performance Committee will endeavor to designate another leg, if this is not possible then the best 2 out of 3 rounds will be counted for CSIOP.
- If this is not possible then the entire selection for the CSIOP will revert to the Pony Jumping High Performance Team Manager Mr. Gary Marshall, who will, select at his discretion, the best combinations to compete at the CSIOP, who ultimately can produce a podium finish.
- **CSIP and CSIYP** - In the event two of the designated events being cancelled, then the entire selection for the CSIP and CSIYP, save the allocations provided by the High-Performance Pony Jumping Team Manager, will revert to the HSI High Performance Pony Jumping Committee in consultation with the SJI Pony Committee, who will, select at their discretion, the best combinations to compete at the CSIP and CSIYP who ultimately can produce a podium finishes at the event.
- **CSIOP** - In assessing the performance of combinations, the Pony Jumping High Performance Team Manager, will give consideration to general measures, as laid out in Art 5.16, of the Athlete Selection Policy for the FEI Pony European Jumping Championships, 2022 CH-EU-P-S, Strzegom, POL 3<sup>rd</sup> – 7<sup>th</sup> August 2022.
- **CSIP and CSIYP** - In assessing the performance of combinations, the HSI High Performance Pony Jumping Committee in consultation with the SJI Pony Committee will give consideration to general measures, as laid out in Art 5.16, of the Athlete Selection Policy for the FEI Pony European Jumping Championships, 2022 CH-EU-P-S, Strzegom, POL 3<sup>rd</sup> – 7<sup>th</sup> August 2022.
- While every effort will be made to adhere to the process set out above the Pony Jumping High Performance Team Manager and the High-Performance Pony Jumping Committee can alter the criteria at any time if they consider it to be in the best interest of the Irish squad travelling to Fontainebleau. In addition, they can choose to leave any selected rider or pony at home if they consider it to be in the best interest of the Irish squad travelling to Fontainebleau pursuant Article 6 the Horse Sport Ireland General Rules.

## Before Departure
