

THOROUGHBRED PERCENTAGE SCHEME CRITERIA, TERMS AND CONDITIONS

TERMS AND CONDITIONS OF THE HSI HIGH PERCENTAGE TB FOAL SCHEME 2022 (FOR FOALS BORN IN 2022)

Horse Sport Ireland have re-issued the Thoroughbred percentage scheme for foals born in 2022. This initiative is supported by the Department of Agriculture, Food, and the Marine.

- Foals MUST have 70% or higher of Thoroughbred blood to be eligible for this scheme. HSI shall have final adjudication of the foals' TB percentage.
- Applicants must be the registered owner of the mare subject to the application and must subsequently be the recorded breeder of the foal.
- Applicants must be resident in the Island of Ireland including Northern Ireland.
- Mares are registered/endorsed in a DAFM-Approved studbook.
- Mare must have been inspected by DAFM-Approved studbook*.
- Stallions must have an Approved/Preliminary Approved or Recognised/Preliminary Recognised classification in a WBFSH/DAFM-Approved studbook.
- An application must be submitted before the 30th of September 2022.
- Applications will be accepted on a first-come, first-served basis once they have met all the eligibility requirements. This scheme allows for 80 successful applications, a max number of 2 foals per applicant.
- In the event of oversubscription to the scheme the awarding of the grant will be allocated to the mare with the best performance ratings or Estimated Breeding Value's (EBV). HSI will also ensure that a balance across disciplines is achieved.
- HSI reserve the right to use performance standard equivalents.
- Foals must be registered in a DAFM-Approved studbook before the 31st of October 2022.
- Prior to draw-down of the €300 payment in 2022 the applicant may be required to provide;
 - Evidence of DAFM mare/stallion classification
 - Evidence of DAFM mare/stallion inspection
 - Evidence of ownership of the mare/ breeder of the foal
 - Have proof of DAFM foal passport submitted to HSI by 31st October 2022
 - IBAN (International Bank Account Number -a combination of letters and numbers that usually include your bank account number and sort code - this can be found on your bank statement or using banking online)
- Provision of funding is subject to a complete feedback form on completion of the scheme.
- Payment will be made in 2022, to the breeders of qualifying foals, on registration of the foal with a DAFM studbook by 31st October 2022.

Checklist

- ✓ The form is digitally signed
- ✓ The applicant is the registered owner of the mare.
- ✓ The mare is inspected in a DAFM-approved studbook.
- ✓ The stallion is Approved / Preliminary Approved in a DAFM/WBFSH - approved studbook.
- ✓ The foal must have 70% or higher Thoroughbred blood to be eligible for this scheme.
