

## 2024 FEI Recognition Card Application, Updates to Existing FEI Recognition Cards & Registrations



IS AN FEI RECOGNITION CARD NECESSARY? An FEI recognition card is required for all FEI competitions with the exception of horses competing in the country they are based in up to CSI2\*/CDI2\*/CCI3\*(S&L)/CEI2\* and CPEID2\*. Participation at any FEI competition in a country other than where the horse is based, an FEI recognition card is needed.
