



## DAFM Autumn Development Series 2024: Dressage

Horse Sport Ireland are delighted to announce the 2024 DAFM Dressage Autumn Development Series, this will include a selection of horse and pony classes. This year, as in previous years, the DAFM Dressage Development Series will run as four legs and a final with over €46,000 in funding available across the league with prizes for 4-, 5-, 6-&7-Year-Old horses and ponies as well as breeders' prizes.

The dates and venues for the 2024 DAFM Dressage Development Series are as follows:

- October 5<sup>th</sup> : (H&P) Ballindenisk
- October 11th – 13th: (H) Meadows EC
- October 25th – 27th: (H&P) Danescroft
- November 3<sup>rd</sup> : (H&P) Coilog

### Notes on 2024 Series:

**It is the responsibility of riders and owners to familiarize themselves with all criteria in this document.**

### Entries:

- All DAFM Development Series classes must run on a pre-entry basis made through Dressage Ireland
- Entries must be made via an online portal. No other form of entry will be accepted
- Ponies can be ridden by adult or pony athletes
- To be eligible to compete in the final the horse:athlete combination must attend one qualifier and achieve a minimum of 65%.
- For Dressage Ireland nonmembers, day tickets will be accepted.

Late entries will be charged double the class entry fee. Late entries can be made via the Dressage Ireland website  
 Entries will be no more than €30 (£25) per class.

### Eligibility:

- Classes are restricted to horses/ponies registered in a **studbook with a valid, listed breed** contained within the studbook passport (UNK is not a breed).
  - Main and Supplementary section studbook animals are permitted.
  - Pedigree recording with an 'UNK' breed code is not a studbook passport and not eligible for entry/prizemoney.
  - Breeder's prizes will only be paid to breeders residing on the Island of Ireland.

### At the show:

The DAFM Dressage Autumn Development Series, delivered by Horse Sport Ireland; the National Federation, must be organized and run in full compliance and adherence of Dressage Ireland rules.

The designated pony combined training classes are as listed.

Combinations entered to compete in these classes are strictly limited to warming up in the designated practice arenas. Any athlete found in breach of this rule by the DI steward will be eliminated from the class. Riders who choose to compete in a leg(s) of the DAFM Dressage Autumn Development Series are consenting to their rounds being live-streamed and/or available for publication on platforms of Horse Sport Ireland's choosing.

- Payment will not be issued to riders unless HSI has received **written permission** from the registered owner of the horse.
- Payment details must be submitted within **14** days via the [online form](#); if received beyond this window, payment **cannot** be processed.
- Breeders prizes will only be issued to breeder residing on the Island of Ireland.

As per the Equidae (Change of Ownership) Regulations 2016 subsection 5, equines must have their ownership details updated within 30 days of their purchase.
